



# 2018 DISTINGUISHED ALUMNI NOMINATION

## Eligibility

Any individual who has been an alumnus for a minimum of five (5) years and meets at least one (1) of the following requirements:

- graduated from any of the Guam Vocational & Technical High School/Guam Community College (GVT/GCC) secondary, postsecondary or Adult Education/High School Equivalency programs;
- earned at least 30 credit hours at GVT/HS/GCC

Selection will be primarily based on materials submitted by a nominator, with consideration given to the following nomination qualifications:

- professional accomplishments;
- philanthropic or public service to the community and/or college;
- achievement of recognition at a national level

## Awards

The award recipient(s) will receive a "Walk of Fame" tile in their honor, which will be strategically located near the Student Center, Allied Health, or Learning Resource Center; a certificate of recognition from the President of the Guam Community College during the Commencement; and will be featured in a photo news release distributed to the local media.

## Nominating Criteria

This is your opportunity to make your nominee shine – in your own words.

- Submit a completed Nomination Form.
- Submit with the Nomination Form a write-up and/or supporting documents highlighting why the individual deserves to be the "GVT/HS/GCC Distinguished Alumni" - maximum two (2) pages.
- To give your nomination the most positive consideration, be sure to address all eligibility criteria.
