# **HOW TO APPLY FOR FINANCIAL AID**

### STEP 1

# Create an FSA ID at <a href="https://fsaid.ed.gov">https://fsaid.ed.gov</a>

- If you are a dependent student, a parent will also need to create an FSA ID.
- The FSA ID is used to electronically sign your FAFSA.
- Keep a record of your FSA ID username, password, email, etc. for reference.

## STEP 2

Complete the 2017-2018 FAFSA (Free Application for Federal Student Aid) online at https://fafsa.ed.gov

If you filled out the 2016-2017 FAFSA, you will use the 2015 tax return information again for the 2017-2018 FAFSA.

#### Be sure to:

- Read and complete ALL sections of the application carefully. Refer to the HELP AND HINTS box for guidance or information about each field in FAFSA.
- Include Guam Community College Federal School Code 015361 for our institution to receive your information electronically.
- Enter your student FSA ID. If student is a dependent, enter also a parent FSA ID.
   Then click on SUBMIT MY FAFSA NOW.
- Print out and keep a copy of your submitted information for your records.
- It will take approximately **ONE WEEK** for GCC to receive your FAFSA information electronically.

### STEP 3

# Follow-Up with the GCC Financial Aid Office

- Follow up with GCC Financial Aid Office after ONE WEEK from submitting your FAFSA application online.
- The GCC Financial Aid Office may be REQUIRED to do verifications and REQUEST an OFFICIAL 2015 TAX TRANSCRIPT(s), 2015 W-2(s), SNAP benefits paid any time during 2015 or 2016 (refer to back of sheet).
- Continuing/returning students should check your GCC email to receive updates on your financial aid status.
- New students will need to first apply for admission to GCC to receive updates.
- If student/parent(s) filed an AMENDED TAX RETURN, refer to back of sheet for the REQUIRED documents.
- Your FAFSA must be complete and ALL required documents submitted before the **PRIORITY DATES** (refer to back of sheet). Otherwise, YOU MAY HAVE TO RELY ON YOUR OWN RESOURCES to pay for tuition, registration fees, books, supplies and other expenses.

## STEP 4

You must complete the APPLICATION FOR ADMISSION AS A DECLARED STUDENT form and submit it to the Admissions & Registration Office along with proof of high school graduation or G.E.D. For more information, contact (671) 735-5331/2/3.

- You must be accepted into Guam Community College seeking a degree or certificate program approved for Title IV funding by the U.S. Department of Education.
- Financial aid assistance will not cover credit hours/course work which will not count towards the completion of student's degree program requirements.

## STEP 5

Students whose FAFSA is complete AND ALL documents have been submitted AND have registered for classes may pick-up a DEFERMENT LETTER at the Financial Aid Office.

- The Deferment Letter is to obtain your student ID and/or book(s) at the GCC Bookstore.
- Pell Grant award is disbursed following certification of enrollment and satisfactory academic progress. Login to

MyGCC at www.guamcc.edu to view your account and financial aid information and if a Net PELL Award check is available for pick-up at the Cashier's Office.

IMPORTANT! If you have not met the <u>priority deadlines</u> for financial aid or your financial aid will not cover your charges, full payment must be made or set up a payment plan with the Accounts Receivable Office (671) 735-5551 no later then 4 PM on the last day to make payment (refer to semester Schedule of Classes).
