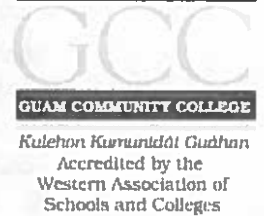

3. MEETING NOTES:

- M/S/C (BO/TM): Moved to adopt the meeting notes of March 15, 2012. No further discussions. Unanimously adopted.

4. OLD BUSINESS/UPDATES: Suggestion was made that meeting minutes should reflect actual corrections as a guide for the Commission to ensure amendments were made.

A. Draft Bill re POST Commission Rules & Regulations/Public Hearing – *Chief B. Camacho*

- There were discussions and revisions made, as follows:

-Page 2 under Section 1.0.1; and page 4, Sections 1.1 and 1.1.4: Chapter 32 should be changed to Chapter 51 and changed accordingly to reflect the correct citation. (Ex.: Title 17, Article 3, Chapter 51; and 17 GCA, Chapter 51, §51306)

-Also to change is on the first page under Reference: the last date the changes were made from May 23, 2011 to March 15, 2012, and to include Chapter 51.

- M/S/C (BO/TM): Moved to adopt the corrections as noted herein with regards to the correct citation and to be amended accordingly. No further discussions. Unanimously adopted.

-Public Hearing: It was agreed by the members that a public hearing will be announced and proper notices issued in accordance with the Open Govt. Law and GCC will issue notices to the media.

B. Executive Director Status- *President M. Okada*

-Chief B. Camacho, Capt. M. Charfauros, and President M. Okada interviewed 2 applicants for the Executive Director position, namely, Ms. Joanne Oliva and Mr. Dennis Santo Tomas. GCC rec’d letter from Ms. Oliva stating she is no longer interested.
