# Board of Trustees Monthly Meeting of September 7, 2011

#### Minutes

### I. CALL TO ORDER

The monthly meeting of September 7, 2011 was called to order at 6:10 p.m., by Ms. Deborah C. Belanger, Treasurer. The meeting was held in the President's Conference Room located at the Student Services & Administration Building.

# II. APPROVAL OF MINUTES - August 17, 2011 Meeting

## 1. President's Report:

<u>Financial Status</u>: Based on the college's financial report as of September 5, 2011, President Okada reported the following: Of the total billing from the Gen-Fund of \$12.456 million, the college has collected \$7.266 million, leaving a balance of \$5.2 million that is still due. Of the total billing from the LPN Vocational Guidance of \$719,000, GCC has received \$539,000, leaving an uncollected balance of \$180,000. Of the total billing from the Manpower Development Fund of \$2.7 million, the college has received \$688,000, with a balance still due in the amount of \$2.65 million. With regard to the Tourist Attraction Fund, the college has received 100% of the funding.

President Okada emphasized that the college continues to work with the Department of Administration in getting GCC's funds released. She noted that though the college is still due \$2.65 million from the MDF, the college anticipates that it will only receive about \$400,000. She assured the Board that the college has been making the necessary adjustments to avoid spending over what we've actually collected.

<u>FY2011 Capital Improvement Projects (CIP)</u> – President Okada noted that as we approach the end of the fiscal year, there are just a few CIP projects that are pending requisitions to vendors. All of the college's construction projects, which are funded by ARRA, are on schedule to be encumbered by September 30, 2011.

<u>U.S.</u> <u>Department of Interior Funding</u>: President Okada reported that the college received an additional \$300,000 from the USDOI to support collateral equipment for the Foundation Building.

In addition, the college resubmitted two grants to USDOI for \$500,000 to support additional energy projects. However, the funds were diverted to the Guam Department of Energy and are now awaiting a MOA from the Guam Energy Office.

<u>FY2012 CIP</u>: President Okada noted that the CIP listing for FY2012 is currently being developed and will be presented to the Board at a later meeting for review and approval.

# 2. Monthly Activities Report

**Student Trustee**: Currently vacant.

<u>Faculty Advisory Member:</u> Ms. Karen Sablan reported on the following:

-Ms. Sablan's letter to the Board relative to receipt of Barry Mead's letter of resignation as President of GCC Faculty Union and as Faculty Advisory Member on the board effective September 2, 2011. Additionally, effective September 5, 2011, with the approval of the Executive Officers of the GCC Faculty Union, Ms. Karen Sablan has assumed the position of President, GCC Faculty Union and the position of Faculty Advisory Member, GCC Board of Trustees.

- The induction of various faculties who serve as advisors on various GCC student organizations.
- -Participation of faculties and students at the Forensic Symposium which commences today, September 7, 2011.
- -School Counselors Conference scheduled to be held next week.
- -Several GCC faculties to participate at the Guam Education Fair scheduled to be held September 8-11, 2011.

### 1. Construction Project Updates

<u>Student Center</u> - Construction continues to progress at 78% completed and is still on track to be fully completed by October 2011 with December 2011 being the actual required date for completion

Northeast Parking Lot across GCC's Shooting Range: This project is at 21% completed.

<u>Foundation Building Renovation:</u> Renovation continues with 20% completed as of date. With regard to the structure of the Foundation Building, GCC received notice from the architects requiring a change order in the amount of \$242,000. The expected completion date for the renovation project is now anticipated to be done by May 2012.

Generator for Building D: As of date, the project is at 40% completed. The expected completion date is still set for October 1, 2011.

<u>Building 200 Renovation:</u> The architectural and engineering design and renderings are still being developed. Based on the availability of funds for this project, the request for bids will probably be put out early 2012.
