The applicant is **exempt** from the requirements outlined in Title 27, Guam Administrative Rules and Regulations, Chapter 3, Guam Peace Officer Standards and Training (POST) Commission Administrative Rules, §3106.

**§ 3106. Standards for Certification of Each Category of Peace Officer.**

(a) Peace Officer Standards and Training Commission certification is a standards-based requirement of all personnel as envisioned by the author of the original legislation and adopted by the Legislature. Consequently, every position under the jurisdiction of the Peace Officer Standards and Training Commission must obtain and maintain Peace Officer Standards and Training certification as defined in these Administrative Rules and Regulations as a condition of employment or as a condition of continued service in any peace officer position.

**Any person who has been serving on a permanent basis as a peace officer on Guam prior to the promulgation hereof (December 30, 2014) and who is currently employed as a peace officer, or was previously employed as a peace officer for at least ten (10) years prior to September 7, 2007, may be certified as a peace officer by the Executive Director without having complied with § 51104(b) and (c).**
