### Scholarship Application Form (Undergraduate)

#### **PURPOSE**

The mission of the Felix M. and Governor Carlos G. Camacho Scholarship Foundation is to provide financial assistance for students pursuing business administration degrees at the University of Guam and the Guam Community College with the expectation that we are investing in the future leaders of our island community.

#### **AMOUNT & NUMBER OF SCHOLARSHIPS**

For Freshmen entering college, the scholarships are awarded up to two years in increments of \$750 per semester. Assuming eligibility is maintained, a total of \$3,000 will be awarded to each recipient over the two years. For those recipients already in college, the amount and length of the award will vary with the circumstances but will only cover the remainder of the student's originally approved undergraduate program. We anticipate awarding three to six scholarships at the end of each school year.

To maintain eligibility for the scholarship, a recipient must make academic progress toward his or her business degree by successfully completing a full-time course load each year that aid is received. The minimum grade point average to qualify for continued aid is 3.0, barring any exceptional circumstances. The scholarship will be discontinued if less than a full-time course load is taken, if an insufficient number of **Liberal Studies- Business track, Accounting, Marketing, Supervision and Management** courses is carried or if the Business related program is discontinued. Recipients must submit an official transcript after each semester to maintain eligibility for the following semester award.

#### **ELIGIBILITY CRITERIA**

1. This scholarship is open to all full-time students enrolled in the of Liberal Studies- Business track, Accounting, Marketing, Supervision and Management Associate degree program, who are residents of Guam.
2. The applicant's standing in the upper 25% of their high school graduating class will be considered and a cumulative grade point average for his/her high school career of at least 3.0 is highly desirable.
3. The applicant's status as a first-generation student attending college will be a major consideration.
4. The applicant must show evidence of financial need. This is to be determined by the Financial Aid Office of the University of Guam or the Guam Community Office.

## **NOTICE OF INELIGIBILITY**

The Board of Directors for the Felix M. and Governor Carlos G. Camacho Scholarship Foundation, their household members and their immediate family members are not eligible to apply for or receive scholarship grants from the Foundation.

Employees of Camacho Investment Corporation, PFC Finance, PFC Investments, and PFC Development are not eligible to apply for or receive said scholarship grants.

Household members and immediate family members of such individuals are also not eligible to apply for or receive said scholarship grants. The Board of Directors for the Felix M. and Governor Carlos G. Camacho Scholarship Foundation will deny all applications from people who fall into the above-described categories.

## **APPLICATION PROCEDURE**

Applications must be submitted by **4:00 pm, Friday, September 30, 2022** to qualify for consideration by the Scholarship Selection Committee. The following material must be submitted:

- a. The Application Form must be filled completely and accurately.
- b. An official school transcript, including cumulative grade point average and class standing at the end of the first semester must accompany the application. For college students, your official high school transcripts and college transcripts are required.
- c. Submit your official academic transcripts with a minimum of 3.0 GPA.
- d. Two letters of recommendation from your high school principal, teacher, counselor or a business or a professional person in the community. Letters from relatives will not be accepted.
- e. A copy of your household's 2021 tax return.

### **1. REVIEW & INTERVIEW**

After a thorough review and assessment of all candidates' submittals, semi-finalist candidates will be selected. These candidates will be contacted for an interview with members of the Scholarship Selection Committee for final selection.

### **2. FINAL SELECTIONS & SCHOLARSHIP PRESENTATION**

The selections made by the Scholarship Selection Committee will be final.

Once scholarship recipients have been notified of selection, a scholarship check presentation will be scheduled. Recipients must appear in person to receive scholarship award with FELIX M. AND GOVERNOR CARLOS G. CAMACHO SCHOLARSHIP FOUNDATION Board Members and GCC representative(s).



## Felix M. and Governor Carlos G. Camacho Scholarship Foundation

The primary purpose of this award fund is to provide one or more annual grant-in-aid to honor outstanding students pursuing an **Associate's degree in Liberal Studies- Business track, Accounting, Marketing, Supervision and Management**, based on the student's declaration of one or more significant achievements which deserves notice and merit.

**Eligible Scholarship Recipients.** All scholarship applicants must meet the following qualifications:

1. The applicant must be enrolled full-time at the Guam Community College.
2. The applicant must be in good standing at the Guam Community College.
3. The applicant must continue to be a student in good standing at the Guam Community College during the scholarship period.
4. The applicant must be declared student pursuing an **Associate degree in Liberal Studies- Business track, Accounting, Marketing, or Supervision and Management**.
5. The award is open to all qualified Guam Community College students who are residents of Guam.

**Amount of Scholarship.** The amount of the scholarship each year shall be \$750 per semester.

**Application Due Date.** - Applications are due to the GCC Financial Aid Office by **4:00 p.m., Friday, September 30, 2022.**

### **Notice of Ineligibility**

The Board of Directors for the Felix M. and Governor Carlos G. Camacho Scholarship Foundation, their household members and their immediate family members are not eligible to apply for or receive scholarship grants from the Foundation. Employees of Camacho Investment Corporation, PFC Finance, PFC Investments and PFC Development are not eligible to apply for or receive said scholarship grants. Household members and immediate family members of such individuals are also not eligible to apply for or receive said scholarship grants. The Board of Directors for the Felix M. and Governor Carlos G. Camacho Scholarship Foundation will deny all applications from people who fall into the above-described categories.
